### **ROLE DESCRIPTION**

**Groundwork South** is recruiting a Trustee to join its Board of Trustees.

Sitting at the centre of Groundwork's governance structure, the Board's main functions are to lead the organisation to ensure a clear purpose and policy framework and develop strategies to achieve the organisation's aims.

Groundwork South is a company limited by guarantee and a registered charity. We are made up of six teams working in the South of England. We are a member of the Federation of Groundwork Trusts that operates across the UK and who are committed to collective action to:

- Help 10,000 people move into education, training and work
- Help 100,000 households overcome fuel poverty
- Improve 1,000 open spaces, involving and benefiting 1 million people

We work alongside local communities, public bodies, private companies and other voluntary sector organisations to support communities in need. Our projects are varied in type and size to achieve the following aims:

- <u>Creating and improving green spaces</u> for community benefit and to reconnect people with nature.
- <u>Training and supporting those furthest from the job market</u> back into work especially for young people.
- <u>Promoting greener living and working</u> to help families and individuals save money, resources and reduce waste.
