JOB SUMMARY

Santa is searching for 2 people to join his top elf team to bring the magic of Christmas to life. You will support the running of the Santa's Winter Woodland (SWW) experience at West Boldon Lodge. The 2 successful candidates will work very closely together to perform a customer-facing role at Santa's grotto and a behind-the-scenes role supporting the smooth running of the event. You will work closely with other staff (other elves and Santa) to deliver a magical and memorable experience for visiting families.

KEY TASKS

- Remaining in character as an elf at all times when customer-facing
- Engaging with families as they (briefly) wait to see Santa in his grotto and building excitement for meeting Santa

- Assisting Santa in knowing who is visiting him in the grotto so he can check his "Nice list"
- Providing families with a gift when the leave Santa's grotto
- Maintaining a Covid-safe environment, including enforcing social distancing
- Cleaning surfaces, items and floors and tidying
- Preparing resources for activities e.g. counting out craft materials, making hot chocolate, etc.
- Assisting other elves with moving resources around the site
- Supporting the flow and story of the whole event, encouraging belief in Santa, and spreading Christmas cheer

EVENT INFORMATION

Santa's Winter Woodland is an interactive Christmas experience that has been running for over a decade. Families with children aged 4-10 years old will visit West Boldon Lodge to meet Santa and his top elf team. Most of the event is outdoors and includes a combination of led-activities, exploration, and performance.
