BACKGROUND



- Following China's imposition of the National Security Law on the people of Hong Kong in July 2020, the UK government introduced a new immigration route for Hong Kong British National Overseas (BN(O)) status holders, providing the opportunity for them and their family members to live, work and study in the UK.
- The BN(O) visa route was expended in February 2022, allowing adult children (i.e. those aged 18-24) to apply for the BN(O) visa independently of their parents. These changes were applied in October 2022.

• From January 2021 to the end of September 2022, 150,600 applications were submitted for the visa, with London deemed a popular destination. The Government estimates that between 258,000 and 322,000 BN(O) status holders, and their dependants, could take up the route over five years.

BACKGROUND

- The Department for Levelling Up, Housing & Communities establish 12
 Welcome Hubs across the UK to prepare for BN(O) arrivals, co-ordinate
 practical advice and improve access to services for the community. The Greater
 London Authority (GLA) is one of these Welcome Hubs.
- In 2021, the GLA created the Welcoming Hongkongers Fund to support Hongkongers, to make them feel welcomed and build a sense of belonging in their new communities.

 The Welcoming Hongkongers Fund was a success as various organisations and community groups designed and delivered many activities that created a positive impact on the lives of many Hongkongers in London.






