

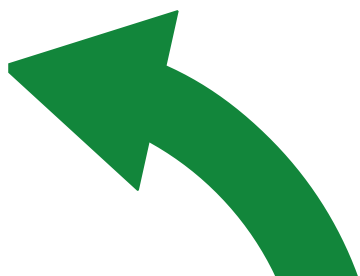

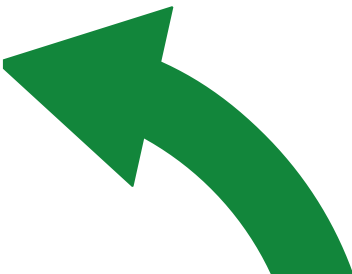

## Overview

Groundwork London is working across the capital to create stronger, more sustainable and healthier communities and creating greater prospects for local people.

We believe that working with local communities to build their resilience is vital in facing up to the challenges of a globalised economy and a changing climate. This means creating green jobs that build wealth in local communities, changing behaviour to reduce energy and water, providing biodiverse, accessible green spaces, supporting businesses to be more responsible and empowering communities to lead activities that improve their quality of life, strengthen their resilience and promote health and wellbeing.

The UK Government amended the Climate Change Act 2008 in 2019 by introducing a target of 100% reduction in the net UK carbon account (i.e. reduction of greenhouse gas emissions compared to 1990 levels) by 2050.

This is otherwise known as the 'Net Zero' Target. This plan outlines our compliance with Action Note PPN 06/21.

## Baseline Emissions Footprint

Baseline emissions are a record of the greenhouse gases that have been produced in the past and were recorded prior to the introduction of any strategies to reduce emissions. Baseline emissions provide a reference point against which emissions reduction can be measured.

Groundwork London's baseline emissions has been set as the year April 2019 to March 2020.

Additional Details relating to the Baseline Emissions calculations.		
<p>Groundwork London has been measuring its emissions from 2019.</p> <p>Offices and buildings carbon (linked to gas and electricity consumption) is calculated across our offices in Waterloo, Hackney, Islington, Hounslow and Dartford.</p> <p>Fleet carbon (petrol and diesel) is calculated via Lightfoot tracking information and largely related to the delivery of Green Doctor (domestic energy support), Water Efficiency support to householders and businesses, and Green Team horticultural programme activity.</p> <p>Staff travel commuting emissions have been based on business journeys by car (and type) or public transport usage. Commuter carbon is gained from an annual staff commuting survey.</p> <p>Total baseline emissions have been calculated 229.6 tCO<sub>2</sub>e</p>

## Emissions Reduction Targets

Groundwork London has committed to reach net zero before the government's current target of 2050. Following consideration and review of our operations and associated emissions we also set a target commitment to reduce our baseline emissions by half (50%) by March 2035. This would require a reduction of approximately 115 tCO<sub>2</sub>e within the next 10 years.

## Carbon Reduction Actions and Plans

- Create Groundwork London cross-team Carbon Reduction / Environment Group (in place since 2023).
- Engage all staff in carbon reduction planning (achieved December 2024).
- Continue to track all fleet vehicles for mileage and driver behaviour (in place since 2019)
- Review fleet options to transition to greener / EV vehicles, as well as options for cargo bikes (by May 2025).
- Provide secure bike park storage at the Morley Street offices (achieved February 2025)
- Audit and review opportunities to reduce carbon emissions from office and other buildings through renewable energy or energy efficiency measures (by December 2025).
- Ensure all premises are procuring green/renewable energy (by Summer 2025).
- Deliver a programme of Carbon Literacy/energy awareness training for staff (started 2023 and ongoing).
- Further work to ensure accuracy and consistency with reporting (by May 2025).
- Further work to fully measure scope 3 emissions (throughout 2025/26).
- Using the above to create a reduction pathway to plot the route to 50% reduction by 2035 and 100% by 2050 (by Summer 2025).

- Commit to continuing our accreditation and best practice associated with ISO14001 including annual NQA audits (in place since 2008).
- Continue to calculate commuting mileage and exploring alternative forms of transport (by Summer 2025).
- Commit to reviewing supply chain green credentials and our ethical procurement commitments (by Sept 2025).

## Declaration and Sign Off

---

This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans.

Emissions have been reported and recorded in accordance with the published reporting standard for Carbon Reduction Plans and the GHG Reporting Protocol corporate standard<sup>1</sup> and use the appropriate Government emission conversion factors for greenhouse gas company reporting<sup>2</sup>.

Scope 1 and Scope 2 emissions have been reported in accordance with SECR requirements, and the required subset of Scope 3 emissions have been reported in accordance with the published reporting standard for Carbon Reduction Plans and the Corporate Value Chain (Scope 3) Standard<sup>3</sup>.

This Carbon Reduction Plan has been agreed by the Board of Trustees and is signed off by Groundwork South's Chairman and Executive Director.
