Working as a member of the Youth Team to engage with targeted participants to provide and promote inclusive opportunities for young people. The postholder will provide a valuable resource for Groundwork North East & Cumbria to enable it to achieve the Trust objectives. Dealing with a variety of Youth project delivery tasks in a diverse and busy internal and external environment, ensuring deadlines are met whilst maintaining quality

KEY TASKS

Key Area: Project Delivery

- Establish and develop face to face relationships with children & young people in targeted areas in line with the project's stated aims and objectives.
- Support the Lead Youth Workers with developing programmes of engagement and participation which meet the long term personal, social and educational development needs of children & young people.

- Provide information, advice and guidance to children & young people, in relation to issues that are
 pertinent to them such as health, education, and employment, and treat their concerns with respect
 and sensitivity.
- Support children & young people in articulating their views on issues which affect them and act as advocates on their behalf. Particularly to support children & young people's participation in local decision making.
- Promote environmental awareness through engaging children & young people to participate in environmental projects.
- Work closely with Groundwork Youth Team Leader and Senior Youth Workers to ensure the successful delivery of the project
- To support in the timely and accurate submission of evidence and the preparation of monitoring reports for Senior Youth Workers to assist in the compilation of claims to for funders.
- With the support of Line Managers / Youth Team Leader work closely with local partners in statutory/non statutory services including local authorities, PCT, sponsors, businesses, voluntary and community groups and other partners, developing local relationships which further the achievement of the Groundwork's objectives
- To raise the awareness of relevant Groundwork Trust Programmes with partners and funders.
- To ensure close liaison with other disciplines in Groundwork to provide local communities with the most appropriate professional service.
- Appraising and satisfying health & safety, legal and other regulations with respect to projects, participants and the general public.

Additional responsibilities

- Passionate about social action and outreach in the community.
- Proven experience of working with either children and young people or other vulnerable groups in a variety of settings.
- Some understanding of, and a sensitive, non-judgemental approach towards the situations, needs and difficulties faced by young people and particularly by young carers.
- The ability to prioritise workload and meet deadlines whilst under pressure, working in a fastpaced environment.
- An ability to work positively as part of a team and independently, seeking support from colleagues where required
- Good written and verbal forms of communication

Sessional Youth Workers will need to flexible. Hours will be allocated to the appropriately qualified workers for the roles that are available.
